



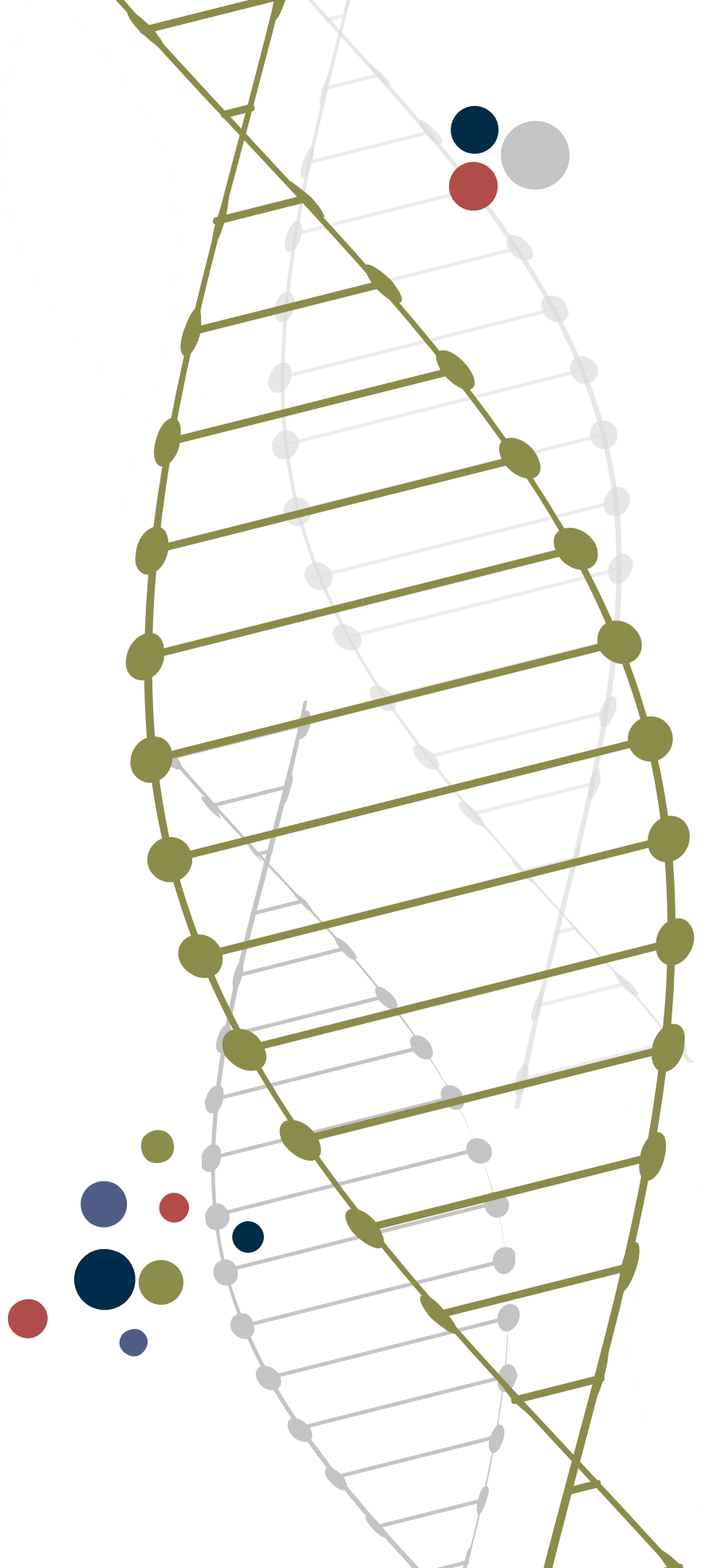

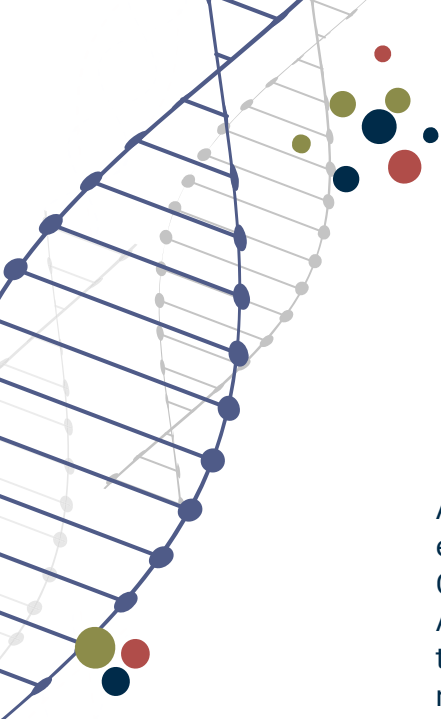
## ACGC PRESIDENT'S REPORT

As the 2023-2024 President of ACGC, it is my honor to highlight some of the tremendous work being done to support the accreditation of 60 genetic counseling training programs. Since much of our day-to-day work revolves around various aspects of program accreditation, I would like to talk about that work first and foremost. As you will see in this report, in 2023 alone, we approved Candidacy Status for six future genetic counseling programs, granted New Program, Accreditation Status for three programs, and re-accredited eight existing genetic counseling training programs. Each one of those program reviews required countless hours of time and dedication by over 50 Program Review Committee (PRC) volunteer reviewers, many of whom served as site visitors, by our Executive Office that provides logistical and administrative support, and by our Board of Directors who thoughtfully deliberated and rendered accreditation decisions for each of these programs.

Additionally, twenty volunteers from the PRC collectively spent numerous hours reviewing Reports of Current Status from 49 programs. Finally, in addition to program review for New Accreditation, Reaccreditation, and Maintenance of Accreditation, the Board of Directors reviewed and deliberated on twenty-one Program Leadership Changes, six Substantive Changes, and four Standards Variance requests. I would like to thank all the individuals who have been involved in the work required for program accreditation, most of whom serve as volunteers.

As if the day-to-day operations of program accreditation were not enough, as you will also see in this report, the ACGC has several committees and workgroups that have been diligently working on important projects to support the organization and many of our strategic initiatives. Here are some key highlights for 2023:

- The revised Standards of Accreditation were published in August 2023! These were the result of an off-cycle standards review by the Standards Committee, driven by the ACGC Diversity, Equity, Inclusion, and Justice (DEIJ) Committee recommendations.
- At the same time, the revised Practice Based Competencies (PBC) were also published, a culmination of over three years of work by the PBC Taskforce.
- We held three virtual office hours hosted by ACGC Board members and the Executive Office staff to encourage increased transparency and communication regarding accreditation processes and procedures.
- The newly commissioned DEIJ Committee started its work this year. Committee members are liaising with other ACGC committees including Standards, Nominations, and PRC to center DEIJ principles across the organization. They also provided a final review of the PBCs prior to publication.



- We signed a Statement of Collaboration with the other genetic counseling professional organizations to develop strategies to promote, support, and sustain DEIJ in the genetic counseling profession.
- We welcomed two new staff members to ACGC: Joseph Jackson as Executive Director and Angela Bond as Accreditation Manager. We are so pleased to have them on the team, and they have made the staffing transition seamless.

As we look forward to 2024, we will continue our work to ensure excellence in education for the future of genetic counseling. In particular, the ACGC Standards Committee will begin its work to perform a scheduled full review of the Standards of Accreditation. This process will be multi-faceted and there will be opportunities for the public to provide feedback at key points in the process. Keep a look out for future related communications.

I would like to end by, once again, thanking all the dedicated volunteers that serve on all of taskforces and committees, the Executive Office staff, and Board members for helping ACGC achieve its mission of advancing quality in genetic counseling education. I am honored to be serving as the current President of ACGC in an extremely productive and successful year for the organization and am excited to see what is in store for 2024.

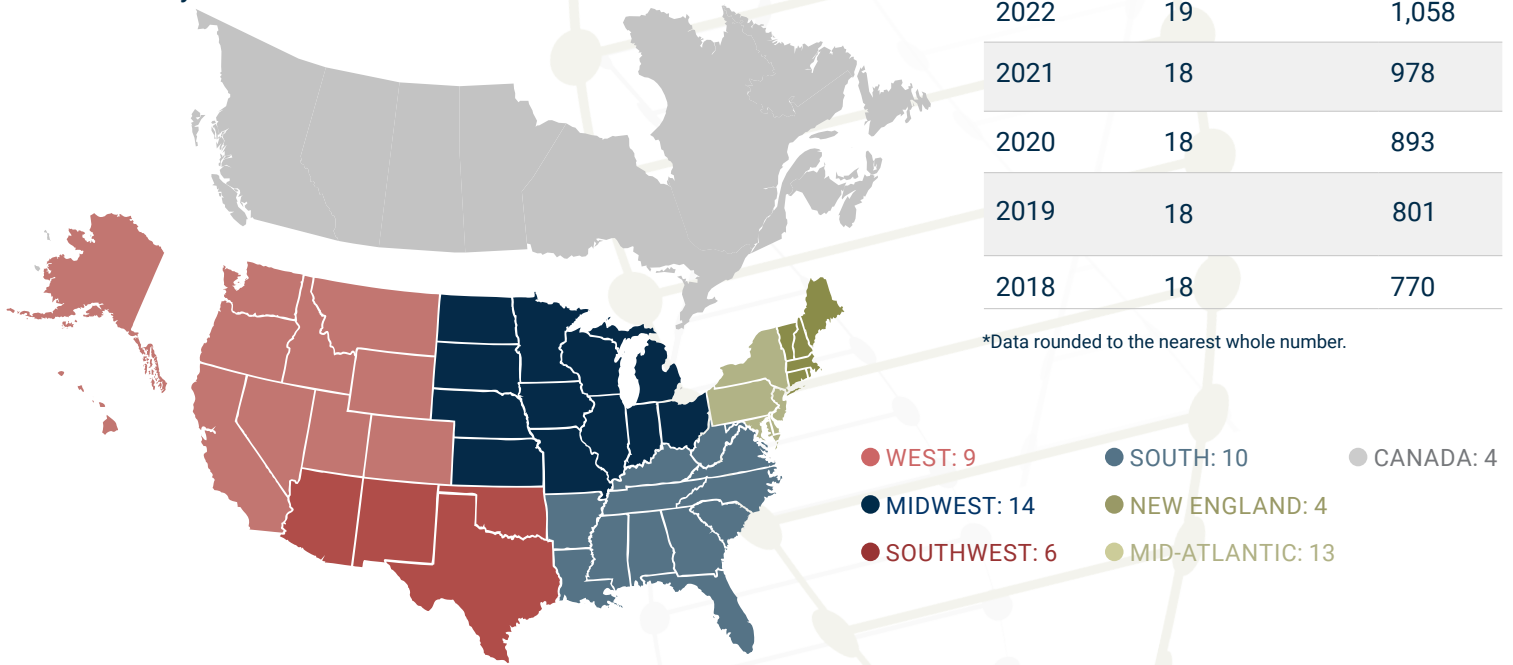

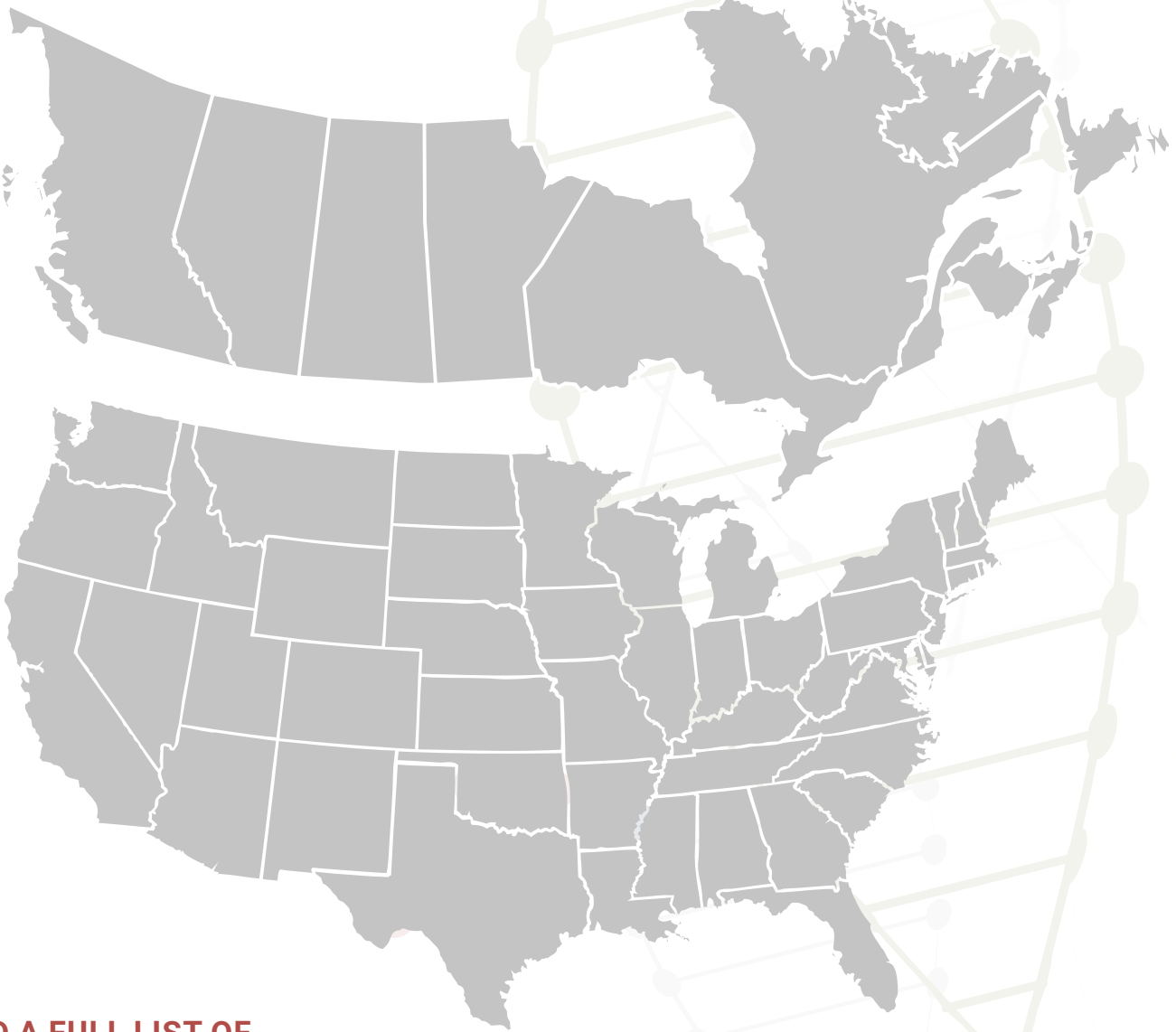
## 2023 REACCREDITATION

## PRACTICE-BASED COMPETENCIES REVIEW

After significant effort from the Practice-Based Competencies Task Force, ACGC Board of Directors, and community partners across the genetic counseling community, a revised set practice-based competencies (PBCs) were released on August 31, 2023. The task force applied the developmental framework, which supports the assessment of learning based on an identified set of skills or competencies. These competencies provide a common language with which to assess learners' progression through and completion of an educational program.

The revised set of PBCs includes seven competencies and 25 sub-competencies. The seven major competencies include:

- **Genetics and Genomics Expertise** - Apply knowledge of genetics and genomics principles, genetic conditions, and testing technologies to the practice of genetic counseling.
- **Risk Assessment** - Evaluate personalized genetic risk.
- **Counseling** - Promote integration of psychosocial needs and client-centered decision-making into genetic counseling interactions.
- **Communication** - Communicate genetics and genomics information to clients, colleagues, and other community partners.
- **Research** - Synthesize the evidence base relevant to genetic counseling.
- **Healthcare Systems** - Demonstrate how genetic counselors fit within the larger healthcare system.
- **Professional Identity** - Embody the values of the genetic counseling profession.

Notable changes to the revised PBCs include a new visual format, concisely written, applicability to the entry-level genetic counselor, and measurability. Accompanying the PBCs, at the above link, is a detailed description of the Task Force's revision process and rationale as well as an explanation of the developmental framework and sample frameworks.



## ACGC STANDARDS

The goal of the ACGC Standards Committee is to monitor, evaluate, and make recommendations to the ACGC Board of Directors for revision of the ACGC Standards of Accreditation.

In 2023, the Standards Committee finished the off-cycle review of the Standards of Accreditation which incorporated the recommendations of the 2021 ACGC DEI Taskforce. Public comments obtained at the end of 2022 were reviewed and incorporated into the Standards of Accreditation.

The ACGC Diversity, Equity, Inclusion, and Justice Committee was consulted as part of this process. The revised Standards for Accreditation were published on August 1, 2023, with an accompanying FAQ document.

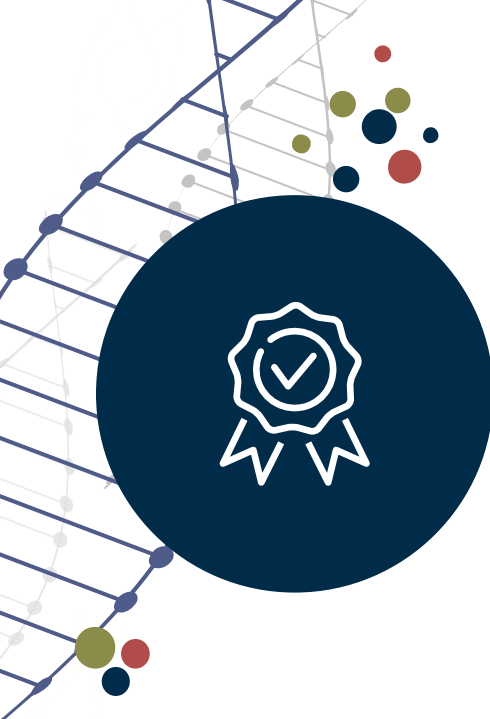
